



Transforming Children's Hospital Foundation into a Cyber Strong Non-Profit Organisation



Children's Hospital Foundation (CHF) was unsure where their cyber security posture stood. They utilised both internal and outsourced IT support but were unclear on their cyber security position, and wanted to ensure that CHF had a strong digital defence. They found a reliable partner in ONGC, who showed them how to turn things around. This led to improved cyber protection overall, supported by a forward-looking partnership.



The Objective: From Zero to Hero in Cyber Security and Compliance

When CHF partnered with ONGC, their main objective was clear: establish a strong cyber security improvement strategy to increase defences, and reach the required level of compliance with imminent amendments to the Critical Infrastructure Act 2018 (SOC1 Act) and the Privacy Act 1988. CHF understood that aligning to the Australian Cyber Security Centre's Essential Eight framework was the right place to start.



The Solution: An Expertly-Crafted Cyber Security Strategy

ONGC approached the project with a clear and structured methodology. Every step was well planned and executed, beginning with a thorough initial audit of CHF's environment. This was crucial because it gave a detailed understanding of the existing systems and highlighted any gaps in CHF's cyber security coverage.

The Road to Enhanced Security

To build momentum and demonstrate value early on, ONGC focused on quick wins within the first 90 days.

These improvements showcased the potential of the long-term strategy, which proved vital to align with the CHF board's requirements.

ONGC then developed a comprehensive 12-month improvement plan.

This roadmap was aligned with the Essential Eight, and aimed at achieving Maturity Level 2. It provided a clear path forward, detailing the steps to boosting cyber security over the year.

CHF was impressed with the results of the initial engagement that focused on cyber security improvements. The initial 12-month period demonstrated significant risk reduction that allowed the organisation to operate smoothly with greater peace of mind.

Following the success of the initial Cyber Security strategy and roadmap implementation, CHF decided to expand the partnership with ONGC, now leveraging ONGC's Reach Secure package. It includes both the existing Managed Cyber Security services and also Managed IT services, which was migrated from another provider. This is a more holistic and proactive partnership that ensures risk mitigation, operational optimisation, and efficiency.
